Minutes of committee meeting 15th February

Meeting opened 7.30

Minutes of last meeting - Accepted as correct .

Matters arising - None

Finance – Treasurer explained we still have slight problems with HSBC internet access but he has a debit card for purchases. The account has G.Drew as primary user and A.Stanford as secondary user, it is relatively easy to alter users so previous problems should not reoccur in the future. Bank charges are £5 per month not per year as previously thought.

He reported he had secured a refund of $\pounds 100$ for bank charges when the account was frozen . All late fees and fees from previous years are now in .

Current bank balance £3864.43, cash in hand £12, total financial assets of league £3876.43.

Trophies – George showed the perpetual trophies selected from Pinnacle catalogue, cost ± 1355 less discount, plus engraving - all agreed.

Shaun reported that the discount on the trophies will be 35%, discount on the accessories (centres etc) will be 50%. He also explained that Pinnace are looking to buy an engraving machine, hopefully at the end of this month.

It was proposed that we also order the individual trophies required as part of the same order -all agreed. The league to pay for 10 trophies per team, winners & runners up. George to visit Pinnacle in the coming week.

Alternative engraving – Steve reported that A&M will still be able to engrave from home .

AGM /Presentation /Summer League registration – It was proposed and seconded that this take place at Broadwater Working Mens Club as it has the large room (and cheapest beer).

Date 30th May – all agreed . A, Stanford to contact BWMCC.

All teams to be advised that as per rules a minimum of 2 members of each team are required to attend the AGM .The meeting order will be AGM , presentation , summer registration .

Summer league fee will be $\pounds 25$.

All teams to be surveyed through results WhatsApp as to interest is Summer League to give Simon ideas on format required . Registration for summer league will only be accepted on 30th May . G.Drew to send message.

Bye Laws -It was agreed that all teams be advised that result cards must be completed with full surnames and initials .

A.O.B. - A brief discussion was held regarding access to venues for young players it was agreed that we must abide by venue rules.

Teams must be reminded that the rules state only 2 county payers can be registered per team .

League to write to Bar Next Door regarding inadequate playing conditions, Steve reported that they have been written to twice in the past.

Teams to be advised that competitions, singles, pairs, cup finals will be at West Worthing Club. To be raised at AGM - that all venues must supply adequate lighting.
